- Review of Financials/Budget
 - July \$248,824.79 is the bank balance
- Approval of Financials

Action Items

- In anticipation of a potential equal sharing partnership with the City of Roseville to offer another round of Facade Grants, recommend that the DRP allocate \$30,000 to continue the Facade Grant program – Wayne Wiley/Mark Vespoli
 - Allocated \$50,000 in first year. The DRP is going to contribute \$20,000 and the city will provide \$30,000 total is \$50,00
 - Approved by Tom Carlson, and Lisa Peters. Approved by all.
- Recommend allocating funds for outdoor seating out decks and shade structures for Vernon Street at a cost not to exceed \$20,000. – Mark Vespoli
 - Since the city is offering to pick up the cost of the decks. It would be good to have the DRP contribute tents and shade structures. Committee needs to discuss shade structure costs.
