# Message from the Board Chair and Executive Director

# Dear Friends,

In 2020 we revised our mission statement for the first time since our founding in 2008. Even though our "reason for being" has not changed over the past 13 years, the new statement more succinctly describes our purpose. Our mission is "to enhance our student experience, assist our teachers and staff and enrich our community by raising funds to support the priorities of the Lewisburg Area School District." "Enriching our community" was arguably the most significant change to our statement; we truly believe that an excellent public school system is a critically important component of a vibrant and thriving community.

The pandemic slowed us down for the last 18 months but our board and advisors are now re-energized and our fundraising reinvigorated, with a particular focus on two capital projects, both of which will be located on the high school campus: **The Dragons' Den,** a new facility located between the baseball and turf fields with public restrooms,

concession stand, trainer's room, and team and equipment storage. The other capital project is a new **greenhouse**, which will support and enhance several curricular and co-curricular initiatives. We are currently exploring an initiative to raise funds for the construction of tennis courts at the high school. Stay tuned for this exciting opportunity.

The bedrock of our fundraising is the **Annual Fund** (unrestricted gifts for current operations), which provides the greatest flexibility to address immediate priorities of the district. And we continue to seek support for our various endowments (see pages 8-13), which underwrite district priorities in perpetuity.

Thank you to those who have supported the foundation in the past. We hope you share our pride in what we have accomplished together. And we hope that you will continue to invest in the ongoing success of our students and their teachers.

The Green Dragon Foundation continues to be a key partner of the school district. From its inception in 2008, the foundation has raised funds to support our students and their families in various ways. Providing nearly \$2 million dollars to the district since 2010, the foundation has supported programming in the performing and visual arts, career development, social and emotional learning, STEM and so much more. These funds are used to augment programs and directly benefit student learning and wellbeing.

Beyond the various enrichment opportunities for our students in the classroom, The Green Dragon Foundation has supported enhancements to the Lewisburg Area School District's facilities. Most recently, the foundation supported the installation of a fly system for the Lewisburg Area High School theater, as well as the construction of a baseball field at the new high school campus.

The foundation is currently working towards a bold campaign for the construction of a concession facility that will enable the LASD to host post-season contests and community-based tournaments. Through the endeavors of other partnering community members, the foundation has begun to raise funds for a tennis court complex.

Members of the community have the opportunity to dedicate their funds to specific projects that they believe are important for our students. The brightest example of this is the Lifting Up Lewisburg campaign that resulted from caring community members wishing to help students and families adversely affected by the COVID-19 pandemic, and sought a means by which they could support those who were experiencing hardships. The success of this partnership and campaign has led to a project that will last well beyond the pandemic.

# Gifts to LASD

Through the generosity of parents, alumni, businesses and friends, The Green Dragon Foundation supports Lewisburg Area School District students, faculty and programs in a variety of ways. **In 2020-21, the GDF provided a total of \$138,275 to benefit LASD students.** GDF donated \$106,850 (\$105,532 financial and \$1,318 in-kind) to the LASD and endowed an additional \$31,425 for future programmatic support. # A Review of 2020-21 Successes

Thanks to loyal and dedicated donors and volunteers, the hard work of The Green Dragon Foundation's Board of Directors, Lewisburg Area School District leadership, faculty and staff, **the GDF** raised \$245,251 in 2020-21, with total revenue of \$289,091.

Your gifts, and your willingness to invest in Lewisburg area students, faculty and programs every year, and especially during these uncertain times, make a difference in every student's life every day.

This additional revenue helps meet the needs of Lewisburg's most vulnerable students, and creates exceptional opportunities for all Lewisburg students. Endowments provide even greater long-term programmatic support of our students; major gifts underwrite projects; and increasing annual support enhances a variety of programs throughout the LASD.

The GDF is governed by a 29-member board of directors (including advisors), led by executive director Ann Glock, and staffed with administrative assistant Tushaar Khurana. In 2020-21, GDF benefited from the work of 18 volunteers who provided 136 hours of service. This past year, volunteer service was restricted due to the pandemic.

# A Plan for 2021-22 and Beyond



# "Lifting Up Lewisburg"

### Update

One of the best qualities of the Lewisburg community is its desire to care for its members. Based on this premise, **Lifting Up Lewisburg: A Campaign to Support Our Schools During this Unique and Challenging Time** was initiated in June 2020. The highly successful campaign raised \$35,050 to support Lewisburg students during the COVID-19 pandemic. During the 2020-21 school year, these funds were used to support students and teachers, helping LASD maintain in-person instruction throughout most of the academic year.

At both Kelly and Linntown schools, the purchase of large outdoor tents facilitated student time outdoors. Desk guards in classrooms and in the cafeteria helped keep students safe. At the high school, the GDF assisted with providing outdoor seating for lunch periods. Many students braved the cold weather to eat lunch outdoors during the winter months. Lifting Up Lewisburg provided additional funding to the Link Crew Program



to help keep e-school students engaged in the high school community. Lifting Up Lewisburg also supported technology needs for Linntown teachers by purchasing **portable document cameras** which support classroom learning as well as remote instruction.

The Lifting Up Lewisburg committee is proud that this campaign resulted in the establishment of a fund to help meet the immediate needs of individual students. Many families in our school district are experiencing difficult times exacerbated by the pandemic. School administrators are able to use this fund when they identify a student in need. Clothing, shoes and a small desk for e-school are a few of the items that have been provided to students. The GDF is currently working with donors to establish this fund permanently to continue assisting our most vulnerable students.

### Outright Gifts of Cash

### Matching Gifts

Does your company have a matching gift program? Many employers will match charitable contributions made by their employees. If your company has a matching gift program, you could double or possibly triple your gift quickly and easily.

#### **In-Kind Gifts**

Contributions of goods or services to either GDF or LASD can provide an ideal giving opportunity for both donor and recipient.

### Bequests and Other Planned Gifts

Bequests are provisions in wills to leave a gift to GDF. Charitable bequests are fully deductible from the estate and can significantly reduce estate taxes on the balance of the estate. Bequests may be specified as a gift of cash or securities, real estate or other property. Alternatively, they may take the form of a percentage of the total estate. A donor may consider a residuary bequest, which is a gift of all or a portion of one's estate after other conditions are met.

# Donate IRA Assets to The Green Dragon Foundation

### TURN YOUR REQUIRED DISTRIBUTIONS INTO CHARITABLE DONATIONS

The Qualified Charitable Distribution, also known as the Charitable IRA Rollover, continues to be a tax-savvy way to give for those who qualify. If you'd like to give to help provide educational opportunities for Lewisburg students, the QCD can help you leverage your support—and minimize your taxation.

This provision allows those who qualify to exclude transfers of IRA assets made directly to The Green Dragon Foundation from their taxable income, and count it toward their required minimum distribution.

To support Lewisburg students by making a QCD, you must:

- Be 70 ½ years or older at the time of the gift
- · Have a traditional or Roth IRA
- Transfer funds, not exceeding \$100,000 per year, directly from your IRA to GDF

#### Benefits include:

Gifts make an immediate impact by advancing GDF's mission

- Gifts count toward your required minimum distribution, now beginning at age 72
- Gifts are not included in, and therefore not taxed as, income for federal tax purposes
- Gifts simulate an itemized income tax charitable deduction for non-itemizers
- Gifts can be directed to support educational, cultural or athletic programs

# How Can I Make a Qualified Charitable Distribution to support GDF?

QCDs are easy; a simple letter of instruction to your IRA administrator begins the process. We will provide one for you, or you can visit the GDF website at www. greendragonfoundation.org to download and print the IRA form and instructions to share with your IRA account administrator.

It's important to consider your tax situation before deciding whether to make a charitable contribution from your IRA. Be sure to work closely with your financial representative or tax advisor to determine whether this tax provision is right for you.

This information is not meant as tax or legal advice. Tax laws are complex and subject to change. Please consult a professional tax advisor to determine how this law affects your situation.

# **Endowment Creation**

Creating a gift in the form of an endowment provides funding for the Lewisburg Area School District in perpetuity. The principal funds are preserved, while a small percentage of funds is available each year for distribution to the LASD. It is a perfect way to establish an enduring legacy in honor or memory of a loved one. It also creates a stream of permanent funding for a donor's particular interest.

The Green Dragon Foundation is focused on matching donor interests to the academic, arts, athletic and support program opportunities that exist throughout the LASD. To accomplish this goal, the GDF seeks support for program-specific endowments, both general and named, the income from which will support LASD programming for the life of the fund. The seven general GDF endowments are:

- 21st Century Classroom Programs
- Athletic Programs & Facilities
- Business, Economics & Entrepreneurism
- Educational Programs
- Health & Wellbeing
- Performing & Visual Arts Programs
- STEM (Science Technology Engineering Math) Programs

# Looking to the Future: The Shabahang Family Endowment

As The Green Dragon Foundation Board Vice-Chair, and corresponding knowledge of the inner workings of the foundation, Jennifer Shabahang understands the importance of endowments to the foundation's mission. In addition to annual fund and priority projects, such as the Dragons' Den, endowments are particularly useful in funding specific requests that may come from a teacher or a grade level. This past year, Jennifer and her husband Mohsen created the Shabahang Family Endowment to support performing arts throughout the Lewisburg Area School District.

Although the priority is performing arts, the endowment is meant to be flexible enough so that the GDF Board of Directors can use the funds wherever they are needed. Jen described the rationale: "For many years I have served on GDF's Strategic Initiatives Committee. This is the group that evaluates funding requests that come from the school district. Often a project will be funded by combining money from several endowments. For this reason, we wanted our endowment to have flexibility. Being able to combine sources allows funds to be used in a timely manner where they are most needed."

Endowment creation is a great way for a family to leave a legacy at LASD. During GDF's Vision 2020 campaign, the Shabahangs supported science programs at the new high school. Mo Shabahang described the endowment creation as being geared to the future. He stated, "Now that one of our sons has graduated and the other two are in high school, we saw the endowment as a way to permanently support Lewisburg students for years to come. Our sons have all been involved in LASD's amazing music programs, so it made sense to make that the priority area." The Shabahangs look forward to seeing the opportunities for students to succeed that will be created through the impact of their endowment.

Miles Foreman was a Lewisburg Area High School student who was tragically killed in a car accident in 2014. As a tribute to Miles, an endowment was established in his name to primarily support poetry and visual arts, and secondarily, band and performing arts. Recently, Miles' grandmother, Anne Foreman, reached out to The Green Dragon Foundation to explore how her art projects could benefit his endowment. She wrote the following to GDF Executive Director. Ann Glock:

"A flash of a smile was never far from Miles' face. Everything he attempted he did with an energy and spirit that surpassed his 17 years. A talented photographer in the "old school" sense of the art, he loved to share his enthusiasm and talent. His generosity and kind guidance were evident to all he knew.

In the spirit of his memory, I am dedicating all pet work I do to enhance the endowment his parents set up in his name at The Green Dragon Foundation. I do not collect or keep any funds. All my contacts are given an explanation and information about what I am doing and why. It is up to them to determine what they decide to donate.

I do my work by utilizing photographs that are provided to me by way of email or text. I work in oil, watercolor or pencil."

The Green Dragon Foundation is proud to collaborate with Mrs. Foreman so that donations from

her artwork can help support Miles' endowment. The pet artwork created by Mrs. Foreman will help contribute to the education of young artists in Lewisburg. As Anne Foreman summed up, she is happy to be doing what she loves and "pay it forward."

During the 2020-21 school year, The Green Dragon Foundation allocated funding to benefit Lewisburg students from the following endowed funds. They have reached the minimum criteria to begin disbursing funds to support their intended purpose—enhancing LASD programs, projects and capital improvement projects.

### The Pat Collins Endowment

This fund supports the **LAHS Technology Lab**, providing the types of hands-on activities that Pat Collins '49 enjoyed when he was a student in LASD schools. He created this endowment to share his love of building and woodworking with as many students as possible. In 2020-21, **\$3,862 was distributed** to the High School Technology Lab for robotics programs.

### The Maryellen (Carter) and Richard L. Keyser Endowment



The Keysers created this endowment in March 2020 to give Lewisburg students exceptional educational opportunities similar to the ones they enjoyed during their years in Lewisburg schools. This endowment was purposefully created with flexibility to allow funds to be allocated to needs identified by LASD administrators and teachers.

In the 2020-21 school year, **\$4,614 was distributed to support the Link Crew program at LAHS**. Link Crew is a program to help freshmen students adjust to life at the high school. Junior and senior students apply to be "Link"

Leaders" and then receive training on how to mentor freshmen. Due to all of the changes caused by the pandemic, the Link Crew program provided some much needed stability for students.

Also supporting the Link Crew program were **The GDF Endowments for Health and Well-Being (\$732) and Educational Programs (\$1,229)**.

# The William H. and Lillian D. Heiner Endowment for Literacy Mastery

This fund supports programs and initiatives for **preschool and elementary students to master literacy** skills. These skills are crucial building blocks for student success. The fund was created in 2016 by Lily and Dave Openshaw in memory of Lily's parents.

In 2020-21, \$600 was distributed to purchase a Novelist subscription at Linntown Elementary. The Novelist program is an interactive database which helps students find books by searching on characteristics such as story elements, tone, theme and mood. Linntown librarian Diane Pauling expressed her gratitude for the program, saying, "It keeps our students reading more and more because they are easily finding books that will personally engage them."



# The GDF Endowment for 21st Century Programs



This endowment provides annual district-wide support for student-focused technology needs. In the 2020-21 school year, \$495 was distributed to purchase 10 podcasting microphones for use by students in the gifted program at Donald H. Eichhorn Middle School.

For several years Lauren Peck's students have written, recorded and edited their own original podcasts. These newly acquired high-quality microphones filter out background noise and amplify vocals, providing students with a professional, authentic experience.

Mrs. Peck describes the benefits of podcasting. "At its heart, podcasting is a creative, innovative way to write and reach a particular audience," she notes. "Students write all the time for the academic setting, but what's different in style and tone when writing for audio? KQED's Youth Media Challenges and NPR's Student Podcast Challenges offer students the opportunity to delve into topics that directly influence youth, their world and their future. Podcasting allows students freedom and flexibility in writing, but forces them to consider how sound and music influence a listener and craft a scene. As my students sharpen these 21st-century skills, GDF has enhanced our project tenfold through the gift of our microphones."

### The GDF Endowment for Performing & Visual Arts Programs

This fund provides district-wide support for performing arts (choral, instrumental, musical and dramatic theater) and visual arts (photography, video, film, painting, drawing, ceramics and sculpture) programs. During the 2020-21 school year, \$380 was used to provide technical support for the creation of a virtual winter band concert for Donald H. Eichhorn Middle School students and their families. Additional support came from funds raised through the Lifting Up Lewisburg campaign.

DHEMS band director Lindsey Eischeid requested the funding when a regular concert was not possible due to the pandemic. Mrs. Eischeid stated, "Despite the difficult circumstances, the students worked very hard all semester. I wanted them to have the opportunity to play in front of an audience, even if we had to do it virtually."





### The GDF Endowment for STEM Programs

This endowment provides **district-wide support for science, technology, engineering and math programs**. In the 2020-21 school year, funds were provided for two exciting programs to promote hands-on learning. The GDF distributed **\$1,900** for **Little Bits STEM Kits for Donald H. Eichhorn Middle School students**. With these building kits students can explore coding, electricity and physics while promoting teamwork and creativity.

At Kelly Elementary \$1,500 was distributed for Ozobot Robots for the thirdgrade team. The small robots help students make the jump from coding online to seeing real-life applications of their written code. The Ozobots provide a foundation for younger students as they move on to more complex robotics.

### The Lois J. Hunter Endowment

This endowment provides annual funding **to support district-wide science**, **music**, **performing arts and social/emotional health programs**. It was created in 2019 by David M. Hunter Jr. in memory of his wife, Lois.

During the 2020-21 school year, \$373 was distributed to purchase **new recorders for every third grader at Kelly Elementary**. During third grade, students begin their unit on the recorder and it is important for each student to have their own, high-quality instrument. Elementary music teacher Liesel Doebler noted that the students are able to apply the cumulative musical skills they are learning at Kelly. Students keep the recorders and will use them in their fourth grade music classes at Linntown Elementary.

### The Josephine K. Machamer Steele Endowment

This endowment provides equal annual funding for learning support and girls' basketball programs. Don and Joanne Steele created the endowment in 2012 in memory of Don's mother, who played on the 1930 girls' basketball team.

During the 2020-21 school year, the GDF distributed **\$420** for an IXL subscription for Kelly Elementary students in the learning support, autistic support and emotional support settings. The program provides web-based content in a wide variety of areas. The program was especially useful during this school year as students could access it during times of remote instruction.

In support of the girls' high school basketball program, \$440 was distributed to provide training equipment for use during practice to increase endurance and reduce injuries.



### The Brandon S. Kramm Memorial Quasi-Endowment



The fund was established in 2014 to strengthen and maintain the LASD's athletic programs and facilities. It was created as a quasi-endowment, allowing GDF to liquidate all or part of the endowment to support an athletic program or facility project within the Lewisburg Area School District.

Over the past few years, GDF utilized more than \$400,000 to construct the Brandon Kramm Memorial Baseball Field. Students used the field for the first time during the spring 2021 season even though a few items were still incomplete. Due to COVID-related delays, the field should be completed during the spring of 2022.

In addition to funding the construction of the Brandon Kramm Memorial Baseball Field, the endowment provided **\$220** to purchase face shields for middle school and high school football players. Also supporting this initiative was the GDF Endowment for Athletic Programs with an allocation of **\$430**. This extra measure helped ensure the health and safety of team members.

You may already know Benjamin Liscum from his historic soccer career as a mid-fielder at Lewisburg Area High School. During his four years playing soccer at LAHS, Ben won numerous awards, including Gatorade Soccer Player of the Year and National Scholar Player of the Year. Ben currently plays Division 1 soccer at Penn State University.

Ben's leadership skills are equally impressive. At LAHS Ben participated in Link Crew, a program funded entirely by The Green Dragon Foundation donors. Ben takes great pride in representing his community and uses his unique platform to do good.

In 2019, Ben initiated a conversation with the LASD and GDF to improve the facilities at the current turf field. At the time he wrote, "Lewisburg Area High

School has a rich history of athletic success. I, along with many members of the community, believe that when our athletes succeed, we all succeed. In the past six years, Lewisburg has captured five state championships and has numerous individual state champions and place winners. Our athletes continuously work to be the best they can be and are never content regardless of their success or failures. I believe that our athletic facilities should reflect the commitment that our athletes invest into their sport, year in and year out. Building a multi-purpose facility at the high school would be a game changer for all of our student-athletes."

Ben's passion, respectful communication and convincing arguments were motivating factors for The Green Dragon Foundation's newest campaign, The Dragons' Den: A Campaign to Provide Refreshments & Restrooms for our Athletes &

**Fans**. We are lucky to have Ben continue to support the campaign and be an advocate for GDF. Of the foundation, Ben says, "The Green Dragon Foundation makes a massive impact in the district and will continue to do so. I feel so lucky to have worked with this organization over the years and am incredibly grateful for the support you've shown so many students like me."

# The Dragons' Den: A Campaign to Provide Refreshments & Restrooms for our Athletes and Fans



Inspired by Ben Liscum's idea to improve athletic facilities, The Green Dragon Foundation is raising funds in partnership with the LAHS Alumni Association and Lewisburg Green Dragons Sports Booster Club to construct the Dragons' Den, a facility to support our student-athletes, their families and our community. This new facility will be located between the turf field and Brandon Kramm Memorial Field. It will contain accessible restrooms, a concession stand, trainer's room and storage areas for team equipment and maintenance items.

This facility will support multiple sports, including baseball, soccer, lacrosse, cross country and eventually softball and tennis. The Dragons' Den will raise the quality of our

athletic facilities to match the caliber of the high school building and LAHS athletic teams.

Of the Dragons' Den, 2021 graduate and former LAHS baseball player, Owen Arndt says, "One of the joys of playing high school sports is seeing your school peers and community members supporting your team. With the addition of a concession/bathroom facility, it will be a much more enjoyable experience for all who attend the games."

The fundraising goal for the Dragons' Den is \$525,000. The LAHS Alumni Association has committed \$100,000 toward naming the concession stand. A steering committee and a special events committee for the Dragons' Den are hard at work planning and implementing fundraising events. The Dragons' Den will truly be a community effort and a fantastic way to show our support to our hardworking student-athletes.
