- Recommend funding a City of Roseville Homeless Navigator position. Funds, not to exceed \$50,000, will be cover two years with a primary focus being homeless support within the District - Brown (tabled)
- Recommend sponsorship of Blue Line Arts Mural Project at a cost not to exceed \$25,000 – Vespoli, Mary Tess Mayall - the board stipulated that this is approved as per guidelines created in the 2019 agreement (Peters, Louthan, carries)

New Discussions:

- **DRP involvement in Bridge Dedication** Mark Vespoli it was decided that the DRP would host a table with handouts at the dedication.
- Façade Grant Program This would be an improvement grant, a city
 partnership with matching funds. The grant would be broader only facades
 and could include landscaping, patio furniture and more. Other options will be
 explored and the former façade program will be reviewed. Various grant
 partnerships are also being looked into (banks, paint stores, etc.)
