Approval of Minutes from Regular Meeting: October 23, 2019 (Peters, Herrick carries). Minutes were approved subject to one discrepancy with the action item from the October board meeting that the DRP will sponsor Downtown Tuesday Nights. With this action item there was some confusion as to if this action item was approved. It was determined by the board that it was approved but that the executive committee will hold a meeting to make a formal approval of the action item.

President's Report – **Mark Vespoli** –Discussed that he talked to John Allard about placing directional signs at Riverside & Atlantic Street exits. The signs would be used to direct people to the downtown district. Capital improvements committee will review.

Action Items

- Recommend sponsorship of Salvation Army Holiday Turkey purchase at a cost not to exceed \$2,000. Steve Palavakis discussed the Salvation Army Christmas distribution for needy families. Distribution date is 12/20/19 at The Grounds. Families will receive Toys, Food, and Clothing. Board discussed what budget category this would fall under. After much board discussion it was approved. (Carlson, Peters carries)
- Recommend rental of Roseville bus banner space for a 6 month
 period at a cost not to exceed \$5,000 Cline Cline discussed the
 cost breakdown of the banners and the types of banners. Banner would
 be located on the back of the bus. There would be two price breakdowns
 depending on the size of the banner. After much board discussion it was
 determined that more information was needed in terms of costs and
 what the banner would say. This action item will tabled until a future
 meeting. The subcommittee will review.

No more than 20 vendors would participate. It will be a harvest theme. It will include food, cocktails, and vendors. There will be various sponsorship levels. Ticket prices will be \$50.00 or \$80.00 for two.
