- * I understand that set up of my truck/tent should be completed before 5:00 PM.
- * I understand that breakdown is not to occur until the music concert has ended or 8:30 PM (whichever comes first).
- * I understand that I will be charged a fee of 10% of total sales (not including sales tax) made during the event and will make payment of this fee to the event organizer Greater Statesville Chamber of Commerce by the end of the event or, on the night of the event, I will coordinate with a Greater Statesville Chamber of Commerce representative to pay the fee within 72 hours following the event.
- * I understand that should I need to cancel, I should do so in writing, not less than 30 days before the event.
- * I confirm that my food truck is licensed/permitted by Iredell County Environmental Health to prepare and sell food for public consumption.
