Rock Springs Rising Curtain: Featured Artist Basic Agreement

This Artist Agreement ("Agreement") is made effective as of the date of final signature, by and between the **Rock Springs Urban Renewal Agency (URA) / The Broadway Theater** (collectively, "The Theater"), and the undersigned artist ("Artist").

1. Purpose of Agreement

The Theater agrees to provide the Artist with a 60-day display period for the Artist's original artwork ("Artwork") at the designated Featured Art Wall location within The Broadway Theater Lobby in Rock Springs, Wyoming, as part of the "Rock Springs Rising Curtain" initiative.

2. Installation Period

The Artwork shall be displayed for a continuous 60-day period beginning on **[Start Date]** and ending on **[End Date]**. The Artist agrees to be available for installation and de-installation at times mutually agreed upon with The Broadway Theater Coordinator. The Artist is responsible for hanging and removing their own Artwork under the supervision of The Theater staff.

3. Sales and Commission

3. **Sales Encouraged:** While the primary goal is exposure, the sale of Artwork is optional but encouraged. The Artist shall set the retail price for all Artwork intended for sale.

4. Promotion and Support

The Theater agrees to provide professional signage, promote the installation on social media and through a statewide press release, and host a pre-show reception/Meet & Greet event in The Loft prior to the installation opening, all to maximize exposure for the Artist.

5. Insurance and Liability

The Artist acknowledges that while The Theater will exercise reasonable care in handling and securing the Artwork, The Theater is not responsible for any loss, theft, or damage to the Artwork during the display period. The Artist is solely responsible for obtaining any insurance coverage they deem necessary for the Artwork.

6. Artist Responsibilities

The Artist is responsible for:

a) Providing all necessary information (biography, pricing, media) in a timely manner.

- b) Ensuring all Artwork is ready to display and suitably framed or prepared for hanging.
- c) Adhering to the scheduled installation and de-installation times.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Wyoming.
