VENDOR SPACE No booth sharing. (1) 6-foot table, chairs, and signs. Space is limited to 6' x 6' booth spaces inside the building. Vendors provide your own table, table coverings, chair and signs.

PREPARED FOOD VENDORS

Are required to provide copies of your current State licenses and liability insurance. Your insurance must list York Region Chamber of Commerce as additional insured.

Reminder: On November 3, 2015, the Town of York voted in favor of adopting the Single-Use Plastic Carry-Out Bag Ordinance that prohibits single-use carry out plastic bags provided by retailers at checkout throughout York. The ordinance took effect on March 3, 2016. Some handle-less bags for wet produce, meat and fish are still permitted. Our market is required to follow this town-wide ban. Vendors must switch over to other options and we have a reusable market bag for sale. Please check with Carol West, Market Manager, if you would like to purchase bags to have available at your booth.
