



## Thurmont Plein Air Guidelines & Application

The 4th Annual Thurmont Plein Air was postponed from Saturday, August 28, 2021 due to potential thunderstorms **and is rescheduled for September 18**. This year the subject will be four of Thurmont's beautiful Parks: Catoctin Mountain Park, Cunningham Falls State Park, and the Thurmont Trolley trail. Thurmont Plein Air is held rain or shine.

1. All artists must be registered by **September 14, 2021** & there is a fee of \$25. **You will pay the \$25.00 fee at check-in on September 18. We do not want to take a chance that your application will not make it in time with the U.S. Mail. At check-in you may pay with cash, check or charge.**
2. If a participant is under the age of 16, they must be accompanied by a parent or guardian during the entire event.
3. On September 18, you will check in at the Thurmont Main Street Center located at 11 Water Street by 8:30 AM. The Center will open at 8:00 AM. **All artists must be checked in by 8:30 AM. When you check in-you will be required to let us know which park you will painting.**
4. Begin Painting at 9:00 AM. You must be back to the Main Street Center (11 Water Street) by 1:00 PM
5. You will need your easel to display your painting for judging. Easels are not available.
6. During the judging, artists may not be near the judging area. Light fare & bottled waterEPT 18 will be provided to the artists during the judging period.
7. Judging will begin promptly at 2:00 PM
8. After judging has been completed there will be an opportunity to sell your painting. No commissions will be charged on any painting that is sold.
9. If your painting sells, it is your responsibility to collect payment from purchaser and pay the sales tax.
