I. Meeting called to order at 2:03 p.m. by President Doug Wagemann

II. Public Comment

- Michelle Raskey, Roseville Theatre Arts Academy had vandalism occur over the weekend – windows smashed in on side of building. Police report filed.
- III. Approval of Minutes from 2/24 regular meeting and 2/17 and 4/12 Special Meetings.

IV. Action Items

- a. District Brochure Liz Krohn reported that staff would like to begin work on a district brochure and need guidance from board. Board expressed desire to save costs and reduce waste by maximizing printing design to include a slick cover that wouldn't change and black/white inside pages for business listings. Businesses should be listed by category. Board would like to see samples from other districts at next meeting.
- b. **Annual Report to Council** Liz Krohn reported that report has been submitted to board for approval. There are several issues that need to be addressed by board before it can be finalized and approved, including potential budget re-allocations and plans for 3% assessment.

- c. Roseville Area Chamber of Commerce Membership Doug Wagemann reported that due to our collaborative relationship with Chamber, their hosting of our meetings, and assistance during DRP formation stages, he is recommending we become members. Annual cost is \$175, enrollment fee will be waived. (Moynier/Vespoli, carried).
- d. **Vote New DRM Representative to Board** Motion to accept Geoff Sakala as a DRP board member representing the Downtown Roseville Merchants (Moynier/Fuhrman, carried).
- e. **Budget Reallocation** –Kat Maudru shared a list of potential costs on projects of interest to give board the opportunity to reallocate funds if necessary to accomplish goals. Motion to reallocate 15% from security to other budget categories. Motion dies due to lack of second. General consensus is to not reallocate any funds in the 2016 budget. Motion to keep budget categories as presented for 2016 (Esparza, Fuhrman, carries). Moynier recommended the DRP establish a Finance Committee to look at budget allocations and make recommendation to the board.
- f. **PBID Assessment Contract and 3% Assessment Increase** Motion to NOT impose a 3% levy increase for 2017 (Moynier / Vespoli, carried).
- g. By-Law Approval- Tabled.
- h. **Civitas Assessment Contract** Motion to approve contract with Civitas to process 2017 assessment for a cost of \$2,750 (Moynier / Fuhrman, carries).
