- Question from Mark Vespoli about cash to carryover. Dave is comparing and reviewing carryover money from 2021. \$45K money was deposits that were not

recorded on budget. Dave Piches is recommending an action item for next meeting to record how it gets dispersed among categories.

- City of Roseville Wayne Wiley Currently working trash pick up. Also checking with
 Gathering Inn to see if they can contribute. Homeless Navigator and Homeless police
 officer wants to know if we would like a report. Looking to establish a presence with
 them. DRP can share discussions directly with the Security, Navigator and RPD. Dave
 Piches recommends inviting them to the next meeting. Kat recommending the
 Dayporter to discuss with Kat separately.
- Gina talking about abatement of old fire station. Exclusive Right to Negotiate. Future site as a mixed use development. 100 residential units and 3-5 commercial spaces.
- Gina also talking about money being available in façade program. Rob Cline is working on creating a downtown map. With activities and other things to offer.
- Tower theatre sold to Hillsdale college plan has not been planned, but there will be speaker series, and well as a facelift. Hillsdale is not local, but trying to get in there and fix it up.
- Gina complaints about refuse on Vernon Street. Garbage bins are paid for through the LLD. Pickup are on Tuesdays. Trying to get more creative with a solution.
- Roseville Chamber of Commerce Rana Ghadban this Friday at 8am is a political forum at Randy Peters for West Roseville candidate. Planning Placer Valley region meeting Oct 19th. Formerly known at Roseville only. Splash is planned too.
- Roseville Parks and Recreation Jeff Nereson Not here, but informed Kat the food truck mania, wine down Wednesday, comedy nights, Friday night flicks,
- Downtown Roseville Merchants Jamie Hazen working on Downtown Tuesday night. Starting with AC/DC tribute band.

New Discussions

- Committee's Goals for 2022 Dave Piches recommending 2 goals per committee.
- Doug Wageman as New Board Member Dave Piches Looking to rejoin the board. Can devote more time again. Looking to see where he is needed most. Kat is recommending a raising money role. Doug mentioned tapping into the California Downtown Association which could be a good resource. Dave Piches asking if we should rejoin based on Doug's research into CDA.
- Fundraising ideas/opportunities for the DRP Jamie Hazen, Dave Piches Dave
 Piches searching for ways to bring in more money. Doug Wageman will evaluate
 the options for fundraising. Board believes the parade could or should be
 bringing more money (an untapped resource). Dave Piches can we try to not
 lose money on the parade. Lisa Peters we do not have any goals set for the
 parade. Committee will work on it.
- Increase DRP Labor force behind the DRP Dave Piches We don't have a volunteer base. Each committee could enlarge their reach of volunteers to be involved in events/activities. Mike recommends that each committee recruit volunteers. Kat asked Dave what the need for volunteers would be. Dave use

volunteers to help in the mural program on the day of. Wayne recommends that there be more collaboration with DRM and DRP. Dave Piches things we should tap into local residents. Doug Wageman referenced the by laws (need to follow) as advisory committee.

- Gathering Inn check list Mike Esparza and Tom Carlson we are putting together
 a list of items. Lisa is recommending that police get involved and issue tickets.
 Lots of discussion about dayporters usefulness. Mike to add trash pickup to the
 list.
- Cash to carryover reserves analysis Dave Herrick already discussed.
- Replacement of damaged downtown sign Wayne Wiley the small downtown
 Roseville signs. What is the process to replace signs when damaged. Also
 recommending more placement of signs. Damaged sign is on northbound on
 Washington and Oak is a wayfinding sign. Signs probably made by Ellis and Ellis.
 It is believed that the sign was created prior to DRP.
