## **Stakeholder Reports:**

Comments or questions not covered in Board Packet Report Tom Carlson is asking about economic development about the fire station. Wayne Wiley mentioned that plans may change because the plans are conceptual. Mixed use of commercial and many residential units. Parking is part of the discussion. Lisa Peters asked about corner of Lincoln and Vernon. New 4 story building with 18 units of residential units. Dave Piches – asked about church and Washington. That is going to affordable housing 89 Unit building with wrap around parking. All low income housing units got leased up quick.

Gina McColl – Belvedere is developing. It will be market rate housing with about 20 units.

Dave Piches asked about the post office development. No developments on that building at this time. Movement is slow to start there. Wayne Wiley — Roseville Venture lab is developing. Generating a lot of activity. Looking for partnerships. Dave Piches asked about roundabout for Atlantic and Vernon. Gina says the plan will break ground in 2 years. It will not be a roundabout and instead become safer as an S curve.

## **New Discussions**

Planter Box Project – Harry White advocacy group for native plants. Implemented in old town Sacramento in April '22. 20 barrels installed. Had to replace about 25% of the barrels so far due to damage or vandalism. Maintenance is part of the program. So far everything is hand watered. Monitored by a team of people. Adds beauty and the cost is very low. Barrels are attached to concrete to avoid theft. Native plants attract butterflies, etc. There are various parts of Roseville already participate with native plants. Maintenance could possibly be easy to get some participation for local plant enthusiasts.

Dave Piches asking what would we need to do. Funding only. Harry White is confident that volunteers could be there. Could be a good project for boy scouts or eagle scouts.

- Capital Improvement Project for 2023 Dave Piches committee met yesterday about next years plans for various projects.
- Free shuttle service in the district Tom Carlson Mentioned that a golf cart shuttle
  in Downtown Folsom. Transporting people from garage to downtown. Folsom has 2
  different free shuttle services. Folsom PBID pays for both shuttle services and it is
  possibly funded by the city. The shuttles are private vendors. Tom will look into it in
  more detail.
- Graffiti Mike Esparza I will report to the police department.
- Dinner on the Bridge Lisa Peters plans are in discussion. Various people are excited and interested. Now looking to collaborate. Goal is to happen in Fall of 2023.
- Bylaw revisions Kat Maudru possibly adding more board members. Extension of terms. And the board can vote on changes without having to get input from the district (property owners). Kat will bring everyone tenure to the next meeting. Will bring it as an action item next month.
- Parade update Stephanie Hill not present. Some questions about costs.
