1. Call to order

The meeting was called to order at 7:05 by Vice President, Herb Weiss

2. Introductions of those attending this evening.

3. Review of minutes from last meeting

Wendy motioned to approve the January minutes as posted. Ernie seconded. All approved.

- 4. President's Comments
  - a. Next meeting will be March 20<sup>th</sup> the 3<sup>rd</sup> week of the month Herb explained this was necessary due to spring holidays
  - b. Northern Gateway Sign handout was shared with the group showing the sign at the Jiffy Lube corner explaining that it will be the same style and we are almost ready to sign the MOU with the state. Question arose about who would be responsible for maintaining the property and we said that is the final change we are working to complete. We will install and maintain the area around the sign and we expect the State to cut the grass on the rest of the triangle.
- 5. The Franklin Precinct Police Report Welcome to Captain Joseph Jamerson and team. Corporal Clements spoke to the group on several topics:
  - May 18<sup>th</sup> will be the 2<sup>nd</sup> Annual Bike Rodeo and there should be a flyer soon
  - -June 8<sup>th</sup> will be Officer Appreciation Day
  - -last night there was an incident in the precinct that originated with a carjacking in DC. The carjackers replaced the DC tags but the police officers spotted the car anyway in the Royal Farm parking lot wearing masks near Delight Road and chased them south to Owings Mills Blvd where they crashed and ran from the car and were apprehended.
  - Hookah Lounge in Chartley Shopping Center owners were evicted on February 13<sup>th</sup> with an order not to return

- -if anyone witnesses an accident be sure to call 911 so an accident report can be prepared and the situation investigated, don't simply email pictures and information.
- Crickett asked about an incident a couple weeks ago where several police cars were in their parking lot. Apparently, there was a situation where 4 high school students were in Franklin Middle School and the SRO officer chased them out and down Main Street.
- Crystal asked about reports on Facebook about catalytic converters being stolen from cars Corporal Clements said their isn't necessarily a spike but just a situation that happens now and then and has so for years.
- 6. The Main Street Manager's Report Crystal Micriotti
- We are planning this year's Bloomin' ArtFest. This event full of vendors, music and food will
  take place outside Franklin Middle School on MAY 11th, 10AM-5PM. Applications for vendors
  who would like to participate are still open, please go to our webpage for more details.
- The 3rd Annual Reisterstown Beer and Wine Festival will be this year one June 1st, 12-5pm. - We are currently accepting applications for our Facade Improvement grant. We will match up
  to 10k towards work that has been done to improve the exterior of a property in the
  Reisterstown Commercial Revitalization District. If you are interested in applying or inquiring

- The RIA National Register Plaque Program will have its next series of unveilings starting in April. We plan to unveil 5 properties. More details to be announced soon.
- Heritage Trails- We are working with a historian and waymarker graphic designer on the HWT.
   We have 4 signs almost at completion and we are looking for an install/unveiling celebration to be in early spring.
- We are working with a sculpture artist on the design of a large kinetic sculpture in our pocket park *Reister's Desire*. With an install in the spring.
- EGGstravaganza will be presented by RIA, MD Horse, and RUMC this year, and will be held on March 24th. There will be a scavenger hunt, an egg hunt, crafts, live animals and of course...the Easter Bunny! We plan on having events at both the MD Horse and RUMC, so please stay posted as we are wrapping up the details.

- Main Street Clean Up Day- This Saturday, March 2nd, at 9:00 am and The Franklin Woodland
   Trails Revitalization Workday will be held on March 9th at 9am.
- The Business Roundtable on March 12th, will have guest speaker: Dave Pyser, Chief Visionary Officer for Visiting Angels of Pikesville / Owings Mills. Held the second Tuesday of every month, these meetings are open to all interested in Reisterstown Main Street with a focus on Main Street business and property owners. Each meeting discusses issues that affect local business, grant opportunities, filling vacancies and attracting new businesses. Come join the discussion centered around making our local businesses thrive. Donuts and coffee provided! As always, we will have a drawing at the end of each Business Roundtable meeting and award a gift card for Reter's Crab House & Grille to a lucky attendee!

- 7. Tonight's Speakers Kimberly May, Senior Project Specialist Baltimore County Department of Economic and Workforce Development speaking on Baltimore County's Summer Youth Employment Program Kim provided a flyer and explained that for the last dozen years Baltimore County has gotten a grant for summer youth employment. This year they have expanded to being able to fund 500 youth aged 14 21 as of July 1<sup>st</sup>. The time from is July 1<sup>st</sup> through August 9<sup>th</sup>, 2024. The time is capped at 25 hours per week and they are paid \$15/hour. Baltimore County pays the wages and handles all liability. They try and place the students registering geographically close to the businesses which register hoping to hire someone. There is a 2<sup>nd</sup> program that is year-round and collaborates with CCBC. It is for 18-24 year olds who are no longer in school.
- 8. New Business/Announcements:
  - a. Local Legislators' announcements/comments:
    - -District 10 Legislators are hosting an Annapolis Night. They will provide transportation, dinner, and a tour of the legislator chambers so you can see them in action. The bus will leave from Owings Mills library. Check your Monday morning email for details and the link to register.
    - Wendy spoke about the new Juvenile Legislation to modify the first legislation, we will wait to see what the final bill looks like. Herb said they didn't remove the part that requires an attorney to be present when interviewing juveniles. Corporal Clements said the bigger issue is that the Baltimore County JOIN program had to be abandoned which was working well in the past and the DJS doesn't have enough funding or manpower to handle all the juveniles.
