### **Rules of Eligibility:**

- Must have an open, stocked storefront open and staffed from June 1, 2024 –
  March 31, 2025
- Conduct business in the provided 10'x14' retail space.
- Provide a Certificate of Liability Insurance listing the City of Evart as an additional insured.
- Hold open store hours Tuesday Friday 10-6pm, Saturday 10-5pm.
- · solicitate funding
- Pay rent on the 1<sup>st</sup> of each month (June-March) at the following rate:
  - \$500 deposit due with the application to be refunded April 1, 2025, upon successful completion of the lease.
  - \$350 June
  - o \$450 July
  - o \$600 August
  - o \$750/month September-November
  - o \$500 December
  - o \$400 January
  - o \$350/month February March

### As a River City merchant, I understand the following rules & regulations:

- If rent is not paid within 10 days of the first of each month, I am at risk of being removed from the program.
- I will provide an employee to represent my shop during those hours.
- If shop closures, early closures or tardiness occurs 3x I understand I am at risk of being asked to leave the program.
- I will attend monthly Evart DDA meetings (Second Tuesday of each month at 8:00 a.m. at The Evart Depot).

- Business acknowledges that Evart DDA/River City is not making any representations, warranties, promises, or guarantees of any kind about participant Business success without limitation, representations about business sales or profit, or public awareness of Business.
- I understand this is a shared space and will respect, as well as promote River City and other participant's space.
- I understand I am also representing the River City program while I am part of the program and will conduct myself in accordance with this understanding.
- I will always conduct myself in a professional manner during business hours.
- I/my business will provide acceptable fixturing, signage and display pieces to sell goods (no card tables, plastic bins, etc. in sales space) and represent River City as a permanent, vibrant shopping experience.
- I am responsible for cleaning my storefront.
- I will respect staff, customers, and other River City participants and conduct business in a professional and courteous and ethical manner without regard to race or religion.
- I will conduct business in accordance with all Federal, State and Local laws.
- My business is and will be an independent enterprise. Nothing in this agreement creates an employment, partnership, joint venture, fiduciary or similar relationship between business and Evart DDA/River City for any purpose.

#### **Private Events:**

- Private 'After-hours' events must receive approval from Evart DDA. (Additional fees may apply to cover utilities, materials, cleaning supplies)
- Private events held within River City will include River City's logo on all promotional materials.
- Private events require that you will be responsible and held liable for the security of other merchants' storefronts and sales space if they are not present for the event.
