500+ Employees	\$1200.00

Membership Applications are approved by the board on a monthly basis.

Membership Dues must be paid in full for benefits to activate.

Memberships run on an annual calendar year cycle.

All membership fees are due each year in January.

Membership dues are based on the number of paid employees.

MEMBERSHIP DUES & PAYMENT POLICIES

Membership Dues are expected to be paid in a timely manner. Membership benefits are subject to expire if renewal dues are not paid in full by March 1st.

First time members joining after July 31st of the calendar year are eligible for a prorated membership at 50% of the published annual rate. These memberships will renew at the full published rate the January immediately following

First time members who join after October 31st of the calendar year will gain membership benefits immediately and be pre-enrolled in membership for the following calendar year.

Membership Dues are not eligible to be part of a service or sponsorship trade.
